## 2.Approval of the Minutes:

SM reported that QMP had approximately 340 members. QMP had renewed their licence with Graham's Dairies.

## 6. Judge-Resigning Judges and Associate Judges

ML said he would like to advise any Judges in advance who is on course for missing the required attendance of 3 Judges Conferences. ML would speak to the Judges in advance of the next conference to let them know about the attendance rule. There are 3 Associate judges, all had been to previous conferences and the Society would like to encourage them to continue. All 3 to be invited to the next Judges conference in 2017, and the cost of hosting the conference to be looked at.

#### 7. Articles of Association:

It had been decided to amend our articles at the last meeting. JW and SB asked if the Board members were still in agreement that the current Articles needed to be updated and amended to become fit for purpose. Unanimous yes. JW, SB and DJ will meet to progress the amendments.

#### 9.Finance:

This was discussed and EH expressed the importance of budgeting each activity in advance of the activity taking place. EH asked each Director to budget for activities they are in charge of leading. eg. Members and Club Roadshows, Youth Development Day, Youth Activities, Judges Conferences, Show Attendance, and The UKJT.

#### 10.JCS Web site:

#### 11.UK JT Publication:

HC reported on the production of the November 2016 edition of the UKJT. ML and MD had received positive comments about the UKJT. SB said there was still strong perception the magazine was not very commercially focused, HC felt this was difficult as herself and The Farm Organisation had purposely continued to make sure farm visits were to commercial farms and certain editions were purely commercially founded. DJ stressed more advertisements should be incorporated to cover costs. HC continued it is a Society Magazine , it is evolving and has come a long way since the first edition in 2015

#### 12.Members Roadshow:

SB stated the Members Roadshow was planned for March 2017. The Roadshow would consist of 3-4 meetings held at different locations in the UK

#### 13.AOB:

Field officers send a weekly report of their activities to the Board.

### Child policy:

DJ read the legal standing of child protection. MD has been CRB checked, EH to check if MD needs to be checked again for the purpose of the Society.

### Risk assessment on farm and first aid:

Risk assessment upon arrival and procedure on farm (ie checking clippers, electric sockets etc) needs to carried out by a qualified person. First aid needs to be carried out by a qualified person.

## Fern Pearston, AHDB Presentation:

The Board meeting closed at this point to allow Fern Pearston of AHDB to give an update on the current trends seen within the breeds PLI and type merit traits after the last review of the Jersey Breed in July 2015. AF highlighted the concern about the 4 linears of the top four listed PLI bulls being negative in narrowness and stature.
